



Modern Slavery Statement for Financial Year 2020/21

This statement is made pursuant to s.54 of the Modern Slavery Act 2015 and sets out the steps that KCM Waste Management Ltd has taken and is continuing to take to ensure that modern slavery or human trafficking is not taking place within our business or supply chain.

Modern slavery encompasses slavery, servitude, human trafficking and forced labour. KCM Waste Management Ltd has a zero-tolerance approach to any form of modern slavery. We are committed to acting ethically and with integrity and transparency in all business dealings and to putting effective systems and controls in place to safeguard against any form of modern slavery taking place within the business or our supply chain.

Our Business

KCM Waste Management Ltd is a family run business that has been operating for 30 years at the above address in the heart of Rotherham. We are a diverse and growing company that operates within the waste recycling sector, covering all of South Yorkshire. As part of our ambition to recycle as much as possible and eventually become a zero-to-landfill site, we continue to invest in state-of-the-art equipment.

KCM's portfolio of suppliers is ever growing and includes overseas organisations that we export recycled materials to, such as plastics and OCC.

Our Policies

We operate a number of internal policies to ensure that we are conducting business in an ethical and transparent manner. These include:

 Anti-slavery policy - This policy sets out the organisation's stance on modern slavery and explains how employees can identify any instances of this and where they can go for help.

- 2. Recruitment policy We operate a robust recruitment policy, including conducting eligibility to work in the UK checks for all employees to safeguard against human trafficking or individuals being forced to work against their will.
- 3. Whistleblowing policy We operate a whistleblowing policy so that all employees know that they can raise concerns about how colleagues are being treated, or practices within our business or supply chain, without fear of reprisals.
- 4. Code of business conduct This code explains the manner in which we behave as an organisation and how we expect our employees and suppliers to act.

Our Suppliers

KCM Waste Management Ltd operates a supplier policy and maintains a preferred supplier list. We conduct due diligence on all suppliers before allowing them to become a preferred supplier. This due diligence includes an online search to ensure that particular organisation has never been convicted of offences relating to modern slavery. Our antislavery policy forms part of our contract with all suppliers and they are required to confirm that no part of their business operations contradicts this policy.

In addition to the above, as part of our contract with suppliers, we require that they confirm to us that:

- 1. They have taken steps to eradicate modern slavery within their business.
- 2. They hold their own suppliers to account over modern slavery.
- 3. (For UK based suppliers) They pay their employees at least the national minimum wage / national living wage (as appropriate).
- 4. (For international suppliers) They pay their employees any prevailing minimum wage applicable within their country of operations.
- 5. We may terminate the contract at any time should any instances of modern slavery come to light.

<u>Training</u>

We regularly conduct training for our procurement/buying teams so that they understand the signs of modern slavery and what to do if they suspect that it is taking place within our supply chain.
